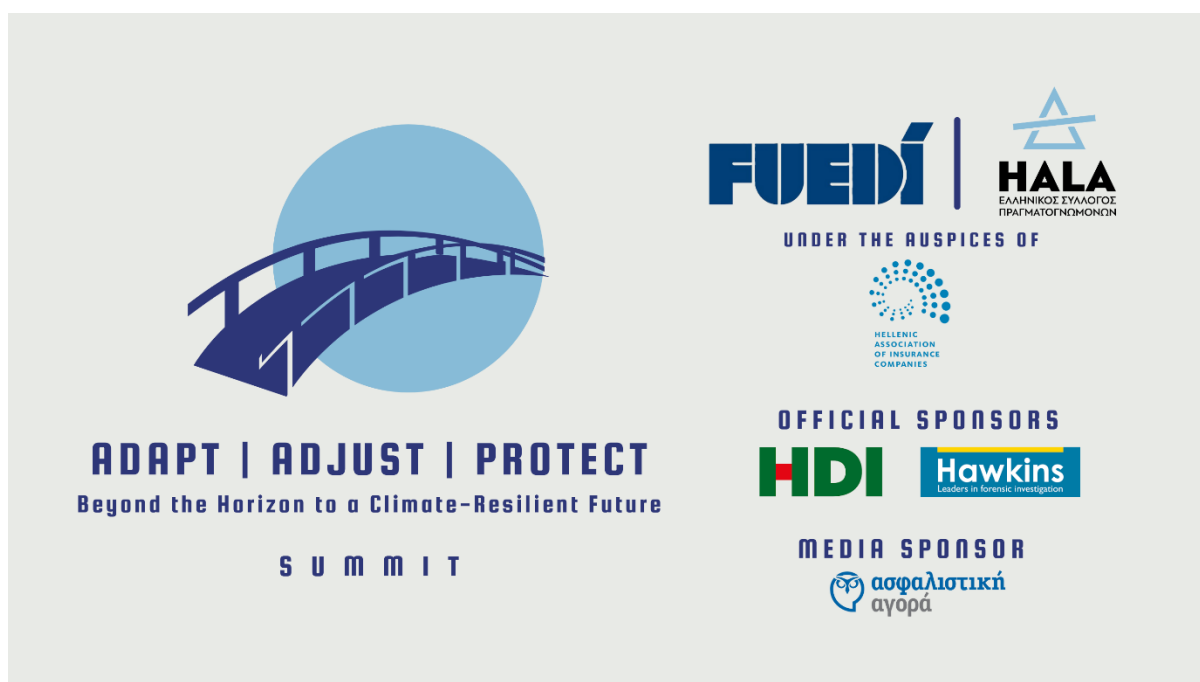


## Privacy and Data Protection Policy

- 1. Introduction** This Privacy and Data Protection Policy outlines how ADAPT | ADJUST | PROTECT ("we," "our," or "us") collects, uses, and protects the personal data of participants ("you" or "your") in accordance with applicable data protection laws.
- 2. Data Collection**
  - **Personal Information:** We collect personal information such as your name, contact details, organization, and payment information during the registration process.
  - **Usage Data:** We may collect data on how you interact with our event platform, including IP addresses, browser types, and access times.
- 3. Use of Data**
  - **Event Management:** Your data is used to manage your participation, including registration, payment processing, and communication.
  - **Communication:** We may use your contact information to send you updates, reminders, and other relevant information about the event.
  - **Improvement:** Usage data helps us improve our event platform and services.
- 4. Data Sharing**

## 7. Your Rights

- **Access:** You have the right to access the personal data we hold about you.
- **Correction:** You can request corrections to any inaccurate or incomplete data.
- **Deletion:** You can request the deletion of your data under certain conditions.
- **Objection:** You can object to the processing of your data for specific purposes.

- **Cookies:** We use cookies and similar technologies to enhance your experience on our event platform.
- **Opt-Out:** You can manage your cookie preferences through your browser settings.
